New 7-Day Quarantine Requirement for Students Arriving from Abroad on or after January 26, 2021

Consistent with updated [Centers for Disease Control guidance](#), students arriving from outside of the U.S. on or after January 26, 2021 **must quarantine upon arrival and remain in quarantine for seven days before accessing UVA Grounds and moving into UVA Housing** (unless your spring housing assignment is a single room with private bathroom.) Students may begin the semester remotely and participate in virtual programming from quarantine. If you have **not** already, please complete the [Spring 2021 Arrival Survey](#) to report your arrival date.

Students are still required to take a COVID saliva PCR test upon arrival in Charlottesville/Albemarle area (more details below) during their quarantine.

<ul style="list-style-type: none">Students will be assigned to University pre-arrival quarantine housing at no additional cost.Meals will be delivered from UVA dining services two times per day throughout your seven-day quarantine period (charged to student meal plans at a level commensurate with the meal plan type.)You will need to stay in your assigned space, separate from others outside the space, and monitor your health for the seven day period of self-quarantine.Please contact Student Health & Wellness promptly if you have any symptoms of COVID. 434-924-5362 (Business Hours). 434-297-4261 (After Hours)	<ul style="list-style-type: none">Students must physically distance themselves from others in their off-Grounds location for the duration of the 7-day quarantine period.If you are unable to maintain physical distancing in your off-Grounds location, you may request assignment to University Isolation/Quarantine (I/Q) space at no additional cost. If you require assignment to I/Q space, please reply to this e-mail and confirm your date of arrival.While in Quarantine, please contact Student Health & Wellness promptly if you have any symptoms of COVID. 434-924-5362 (Business Hours). 434-297-4261 (After Hours).

COVID-19 Testing

All air passengers are required to get a COVID-19 test within the 3 days before their flights to the U.S. departs, and provide written documentation of their laboratory test result (paper or electronic copy) to the airline or provide documentation of having recovered from COVID-19. **As previously instructed, students arriving directly from outside of the U.S. are required to receive a COVID saliva PCR test immediately upon arrival on Grounds or in the Charlottesville/Albemarle area.** Upon arrival in Charlottesville, visit UVA's [Walk-In Saliva Testing](#) on the 3rd floor of the [UVA Central Grounds Parking Garage](#) at 400 Emmett St. during designated walk-in hours on a first-come, first-served basis.

- Monday-Thursday: 8:00am - 4:30pm
- Friday: 8:00am - 3:00pm
- Sunday: 1:00pm-4:00pm
